

We're at an inflection point where technologies are converging, with Al becoming integrated across a multitude of software and driving accelerated breakthroughs across areas spanning drug discovery, autonomous driving, automation, and a variety of others. Innovation never stops, building on the foundation of prior breakthroughs and redefining the investment landscape of today.

In recent memory we've had a few substantial technology platforms changes – computer, internet, smartphones, social media, and the current frontier is Al. Historically, shifts in technology platform have driven changes in tech dominance, creating opportunities for

innovative smaller companies. Alphabet is one of the few companies that has been dominant across several platforms including internet, smartphones, and social media. With all eyes on Al as the platform of the future, companies are investing heavily to solidify their dominance.

Like innovation, markets are constantly evolving. As adoption rises, companies at the cutting edge of the technological revolution have the potential to become a larger part of the broader market or be acquired by more established peers. Maintaining exposure to a diversified group of the key structural themes currently shaping innovation can benefit investors without requiring them to correctly time their thematic exposure.

Why the Global X Digital Innovation ETF Model Portfolio

The Digital Innovation Portfolio includes diversified thematic exposure that stands to benefit from the global wave of digital transformation. This transformation blurs the lines between the digital and physical world, with Big Data themes such as Cloud Computing connecting with industrial applications to improve automation and efficiency. Data has become a critical resource in the 21st century. Harnessing its potential to improve efficiency is a key area of structural change currently shaping society. Themes are carefully chosen based on their disruptive potential while ensuring thematic diversification through including exposures to themes disrupting different sections of the economy.

WHY THEMATIC EQUITY & WHY GLOBAL X DIGITAL INNOVATION





Thematic equity is long term in nature, with themes typically remaining in the portfolio for several years. Historically, there have been one to two theme changes per year, with majority of the allocation changes focused on the weighting between themes. Allocation changes are typically made quarterly but may occur more or less frequently based on the market environment. The chart below illustrates the positioning of themes since the portfolio's inception, for example:


- Defense Tech was added to the portfolio in 2024 due to geopolitical tailwinds. The inclusion of this theme has been highly beneficial to both absolute and relative performance during 2025.
- Data Centers & Digital Infrastructure was added to the portfolio in 2024 to benefit from Al's global expansion.
- U.S. Electrification was added to the portfolio in October 2025 to benefit from Al's growing power demands. The inclusion of this theme had the added benefit of boosting portfolio diversification.

Global X takes a targeted yet diversified approach to managing thematic portfolios. This is a key differentiator relative to some competitor products. ETF selection focuses on pure play exposure to select themes to minimize overlap within the thematic portfolio and with core beta exposure. Diversification is an important consideration in managing our thematic model portfolios, assessing the factor and exposure risk to understand how themes are likely to work together in a portfolio over time.

How to Use Thematic Equity

A Core-Satellite approach is a useful way to think about this future focused exposure. Thematic equity can be used as a satellite exposure within a diversified portfolio. It's important to establish a framework around the long-term inclusion of thematic equity, setting limits that ensure this exposure can augment the rest of the portfolio without adding meaningfully to risk. We've done extensive analysis into the appropriate levels of thematic equity at different risk profiles. Please refer to our Scaling Thematic analysis for more information.
